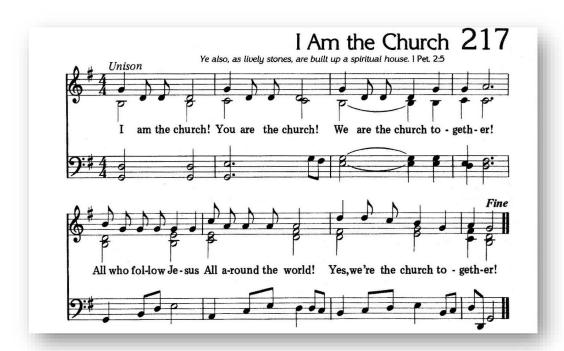

Meeting was opened by Jeff Creighton. Prayer was offered by Rev. Bette. Prayers for Rev. Bette.

Minutes from last year were reviewed.

Old Business: Sound system was discussed last year. The hearing loop is working quite well. May need to order more receivers. Deacons reported that they have ordered two more receivers.

New Business: A proposal was made by Joe Cifaldo to change the By-Laws on the financial end concerning the 5% and to go to $7\,1/2\%$. Jeff Creighton asked how much is enough. The investment gains seen over the last 5-10 years doesn't mean that we will see that over the next years. The investment account is \$679,000. Proposal withdrawn.

Pat Weaver reported regarding the discretionary fund that they have received donations. They have been seeing a lot of need. The discretionary fund could be included in the budget and a meeting could be called as the need arises. This would be the most transparent and direct method. The discretionary fund is allowed to withdraw \$3,600 a year. They gave over \$10,000 last year.

Reported that there is water damage in the sanctuary. Is there a plan to address this? Believe that it is caused by wind driven rain going into the vents. They plan to eliminate those on one side.

Rev. Bette reported that a labyrinth would be lovely for the community and for the church. Keep in mind that the study has been done regarding the cost.

From the priorities addressed two years ago, the parking lot was chosen. Then the carpeting and then the labyrinth.

Becky Ruggieri brought up a discussion about having a youth minister or a part-time youth minister. Need to think outside the box. Jeff Creighton asked if the outreach committee could handle expanding the roll and growing the church and Sunday School for all children. Need to offer something for the parents. Those on the outreach committee are Rev. Bette, Becky, Stacy Rome and Debbie Collamer. Rev. Bette reported that she has a plan. We each have a calling.

Motion made and seconded to approve the minutes from last year. After a vote the motion passed.

Nominating Committee:

Jason is going off as Trustee. Thank you, Jason. Nomination was made and seconded for Sterling Robinson to go on as Trustee. After a vote, the motion passed.

January is going off as Deacon. Thank you, January, and thank you to Gayle White.

There will be an appreciation of outgoing officers.

Reconfirmed that the meetings are always open for anyone to attend. This includes all boards, committees and the church council.

Nomination was made and seconded for Michelle Bradley, Wes Ames and Karen Carpenter to go on as Deacons. After a vote, the motion passed.

Board of Education: There are three nominations; Michelle Bradley, Kathy Lanphier and Robin Quinn. Kathy Lanphier agreed to stay on. Motion made and seconded to accept the nominations. After a vote, the motion passed.

Reported that missions' funds and memorial funds are not combined. Missions is in charge of the committee. There are two nominations; Irene Maxcy and Valerie Miller. A motion was made and seconded to accept the nominations. After a vote, the motion passed.

Will discuss delegates to State and National later on.

Those elected annually have agreed to stay on.

Motion made and seconded to accept all of these people to these boards. After a vote, the motion passed.

Pastoral Relations: Three terms are up and they have agreed to stay on. The Trustees and the Deacons will appoint their representative to the Board. Motion made and seconded to accept. After a vote, the motion passed.

Historian: Motion made and seconded that we keep Linda Lent on as historian. After a vote, the motion passed.

Council Member at Large: Sterling's term needs to be filled as he is going on as Trustee. Explanation of the duties. They bring concerns to the appropriate board and they are to attend the Council meetings. Nomination was made and seconded for Clint Lanphier. After a vote, the nomination passed.

Explained that if you want the pastor to visit someone, you need to see the pastor and not the Member at Large. This is explained in the By-laws.

Hospitality Committee: There are three on there. Robin Quinn and Carolyn Robinson have agreed to stay on. Nomination made and seconded for Robin and Carolyn. After a vote, the nomination passed.

Thank you to the nominating committee.

Nomination made and seconded for Jeff Creighton as the Trustee to serve on the Pastoral Relations Committee. After a vote, the nomination passed.

Budget: Proposal for the pastor is 3.2% be built into her salary. Feeling is she should get more than that. Motion was made and seconded that we add another \$1,000 to the allowance. This \$1,000 can be used wherever she wants to. After a vote, the motion passed.

Proposal to put COLA increase for next year under Old Business.

Church: \$39,838. Moved to accept. Will approve all items at once.

Music: One correction made to CCLI it should be changed from \$441 to \$464.

Outreach: There is an outreach plan for Easter.

Board of Education:

Office: One correction. Administrator should be \$6,500 not \$650. Motion made and seconded to give the administrator a raise of another \$1 per hour. Noted that both administrator and custodian are church members. Add \$1 per hour for the custodian. Carolyn Robinson refused. Motion failed.

Treasurer: \$100 gift to Kathy Lawrence.

Miscellaneous: One change. The minister to National and a Delegate figure should be switched.

Motion made and seconded to accept the budget as written, including the increases, of \$126,762. The delegates to National include the delegate and the alternate. Should encourage other people to be delegates and for others to go to the National Meeting. After a vote, the motion passed.

Delegates to State:

Robin Quinn will stay on.

Kathy Lanphier will stay on.

Nomination was made and seconded for Kathy Lanphier, Robin Quinn and Pat Weaver. After a vote, the motion passed.

National: Spokane, Washington.

Nomination for Clint Lanphier and he declined.

Nominations made and seconded for Robin Quinn, Becky Ruggieri and January Peavey. Nomination withdrawn.

Nomination made and seconded for Becky Ruggieri and Robin Quinn to go to National. After a vote, the nomination passed.

Appreciation of outgoing officers will be done on a Sunday morning in the near future.

Approval of written reports: Motion made and seconded to accept as written. After a vote, the motion passed.

Year-round delegate to National. Nomination made and seconded for Marcia Cifaldo. She accepted. Would like someone else to go. January Peavey volunteered. After a vote, the nominations passed.

Oral reports: Motion made and seconded to approve all oral reports. After a vote, the motion passed.

Financial Reports: Motion made and seconded to approve all financial reports. After a vote, the motion passed.

Motion made and seconded to adjourn. After a vote, the motion passed.

The meeting was closed at 1:29 p.m. With singing of "I am the Church".

God has indeed been good to our church in the past year. The overwhelming generosity of the congregation is proof the spirit of the Lord is alive and well at SCC. With many vital maintenance projects completed, the generosity that brought those projects in under budget can now be seen increasingly in places that speak directly to our true mission of worshiping God and helping the less fortunate. The giving of these three funds in 2024 are Missions \$17,854, Discretionary Fund \$16,552 and Bowes Fund \$6,800 for a total of over \$41,000. An amazing accomplishment for a church our size!!!

"Remember this: Whoever sows sparingly will also reap sparingly, and whoever sows generously will also reap generously. Each of you should give what you have decided in your heart to give, not reluctantly or under compulsion, for God loves a cheerful giver. And God is able to bless you abundantly so that in all things at all times, having all that you need, you will abound in every good work." 2 Corinthians 9 6-8

STAFF: As usual, our Church staff has done an excellent job in the past year. Rev. Bette continues to give meaningful and biblically based messages and mid-week morsels. Bette being elected as Moderator of the State Association is a testament to her hard work and a very positive reflection on our Church. Thank you, Bette!! Beverly always goes above and beyond as our music minister. She works tirelessly to help bring the spirit of the Lord to our Sunday morning worship through music. The Bell Choir is a perfect but just one example of her hard work. Everyone should take the time to thank Beverly, the Choirs and anyone else involved in our Music Ministry.

Carolyn, our Church administrator continues to show how important this position is to our Church. She keeps the church office running smoothly and the congregation informed by getting all church publications (bulletins, reports, annual reports, newsletters, emails, etc.) out accurately and on time! While in the office she is always helpful with taking and making calls and to help deal with any issues that may arise!

In July Susan Lombardo retired from her position as Custodian. Thanks Susan, for a job well done. After a month-long search for a replacement, Karen Richards stepped forward to fill the position. When you get a moment thank Karen for her hard work and maybe even lend a hand. While not a paid member of the staff, Pat Weaver deserves a big thank you for all that she does as treasurer. In addition to the Church's regular operating expenses, she does the check writing and accounting for the Discretionary and Bowes funds as well.

FINANCES AND BUDGET: Our Church has met the challenge yet again in 2024 of dealing with the post Covid increase in the cost of doing business. With an approved budget of \$126,917 in 2024, our total operating expenses were approximately \$121,000 The average weekly offering for the year was \$1,662. This represents a decline from the 2023 weekly average of \$1,691 The Trustees have proposed a budget for 2025 of \$127,507 which is an increase of less than one half of one percent from last years approved budget.

In September the Trustees made the decision to pay off the paving loan with funds from the Church investment account. With the stock market at record highs and due for a correction, the decision was made to take some profits and avoid the finance costs of the loan.

INVESTMENT ACCOUNTS: Another year of yet again well above average stock market returns, has blessed all four Church investment accounts with record year end values. Despite helping fund a long list of absolutely necessary maintenance projects over the last nine years, the Church investment account has more than doubled to a value of \$753,354. While recognizing that the market can giveth and the market can taketh away on a short-term basis, these accounts will continue to provide a vital source of income over the long term if we continue to limit distributions to appropriate levels.

The year end value and the 5% that is allowed from the four investment accounts in 2025 are listed below:

Church Account: \$753,354 5% 33,111 Bowes Fund: \$411,091 5% 16,867 Discretionary Fund: \$88,558 5% 3,804 Building Fund: \$63,634 5% 2,795

MAINTENANCE PROJECTS: In late winter the Flower room received a much-needed makeover. The ceiling was reframed and insulated. Walls and ceiling were sheet rocked and painted and new lighting and shelves were added.

In May a second oak stair railing was added to the steps on both ends of the chancel. Many thanks to Tim Andrews and his crew for their excellent work. Tim donated the cost of the work in memory of his parents, Paul and Janet Andrews!!!

The sound system is an ongoing project that should be completed early in the new year. With the addition of two new speakers, all four speakers will be mounted on the wall with multi directional wall brackets. Once the problem of an already overloaded amplifier is solved, the project can be completed. The Trustees would like to thank Cathy and Russell Lawrence for their very generous gift of the new speakers and wall brackets.

While the list of necessary projects is getting smaller, there is still work to be done. The fire escape has been on the list for a few years, so that should get sandblasted and painted this year. The other top priority is some much-needed gutter work.

The choir room that is on the left side of the organ, needs the same attention the Flower room received.

The storage space that is immediately to the right as you enter the Sunday School wing needs some new sheetrock and insulation.

The Trustees would like to thank all the boards, committees and Ladies groups that helped make 2024 a very successful year at SCCW. And we must never forget all the individuals that donate their time and hard work behind the scenes.

Mark took this responsibility seriously and welcomed Eric Overlock, Carolyn Robinson, and Susan Lombardo to the board. A few months later Bob Barrett was invited, all of whom accepted with enthusiasm.

As directors of the Bowes fund, each request for assistance that we receive is thoroughly reviewed and discussed among us. We take the time to understand the specific circumstances of each request, and after careful consideration, we vote on whether to approve the request and determine the appropriate amount of aid to provide. This process ensues that our giving is targeted and effective. All approved requests are signed off by a trustee from SCCW, which adds an additional layer of accountability and transparency.

To achieve our objectives, we follow a carefully crafted investment strategy similar to that employed by all SCCW funds. This strategy ensures that our charitable contributions are sustainable and effective. We limit our annual giving to 5% of the average of our investment gains over the past three years. By adhering to this disciplined approach, we not only protect the longevity of the funds, but also enhance our capacity to help more individuals and families in need.

Since July 2024, the current board members have had seven in person board meetings and have successfully awarded a total of \$6798.00 during the current year to support the poor and needy in Warren, as the Bowes will instructs.

This board is committed to meeting quarterly or as needed to carry out our important responsibilities as outlined in the will. We will continue to make a positive impact on our community and those in need. We are dedicated to ensuring that the Bowes Fund remains a vital part of SCCW's mission for generations to come.
